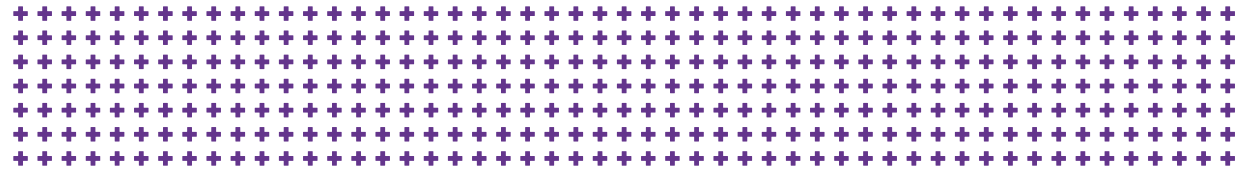

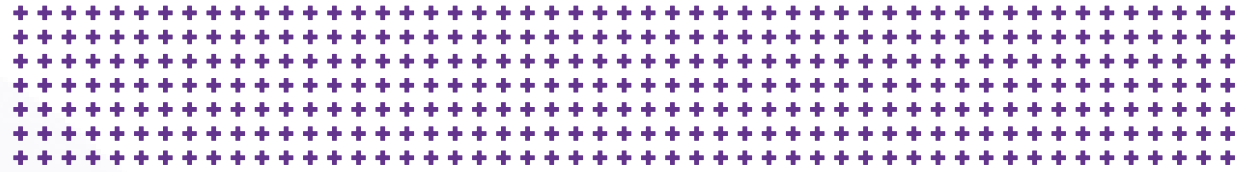

Enhanced Health in Care Homes

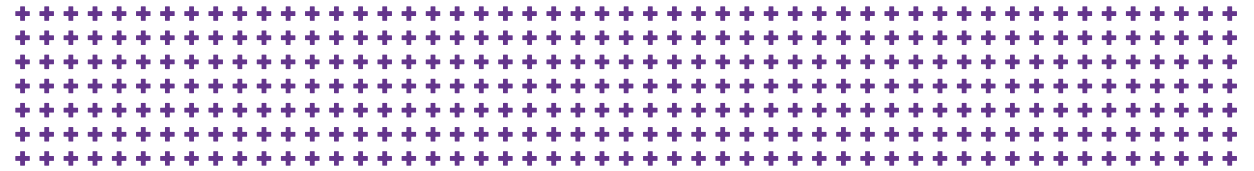

Programme Overview:

- Started in 2014 with six care home vanguards.
- Aims to reduce unplanned hospital admissions through improved health and social care collaboration.
- Contractual requirements for care homes:
- Alignment with primary care networks (PCNs)
- Weekly multidisciplinary team visits
- Comprehensive assessments for new residents
- Focus areas: personalized care, structured medication reviews, care for residents with learning disabilities and autism

Care Home Health Services Update:

- Key priorities: nutrition, hydration, falls prevention, mental health support
- Emphasis on multifactorial falls interventions
- Enhanced health in care homes remains a key policy area; upcoming frameworks for frailty and dementia
- Care homes encouraged to contact local commissioners if not receiving services (participation is free, reduces primary care demand)
- Structured medication reviews should involve direct communication with residents/carers
- No current formal oversight of GP practices in care homes



Enhanced Health in Care Homes

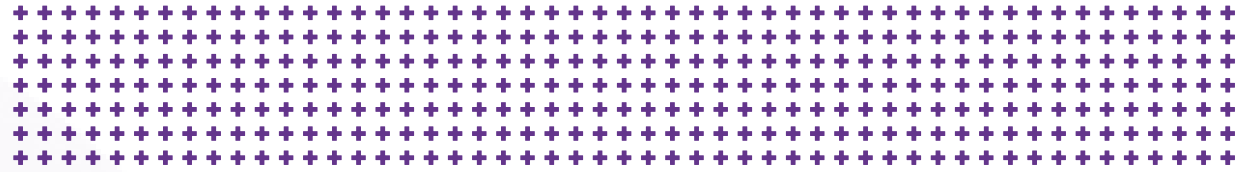

Care Home Service Impact Assessment:

- Need to measure the impact of the modern service framework
- Enhanced Self and Cairns highlighted as key components
- Collaboration between healthcare staff and care home teams is crucial
- Expertise of care home staff acknowledged
- Questions raised on end-of-life care and access to rehabilitation services; local ICB leads should address
- Challenges in predicting end-of-life timelines and improving rehabilitation provision noted

Challenges in Care Home Technology:

- Digital support for care planning, data sharing, and communication is inconsistent; no national standard
- Importance of system interoperability highlighted
- Examples of successful local collaboration between care homes and healthcare providers shared
- Need for improved communication and partnership between NHS and social care emphasised



Emollient Fire Risk Awareness webinar

Overview of Fire Risks:

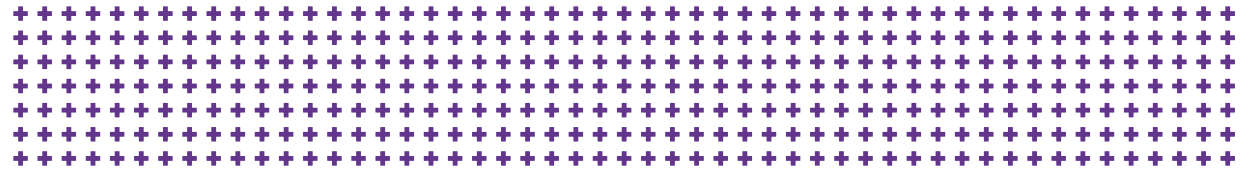
- Emollients are widely and safely used but can become fire hazards when dried on fabrics and exposed to heat.
- Both paraffin and non-paraffin emollients can act as accelerants.
- Key risk factors include smoking, portable heaters, and unsafe cooking practices.
- Case studies (Jack and Robert) illustrated real-life consequences.
- Fire risk assessments are essential, but frontline staff may lack full understanding of mitigation measures.
- Research by Professor Sarah Hall highlights fabric flammability with dried emollients, underscoring the need for awareness and prevention.

Patient and Carer Safety Advice:

- Avoid open flames when using emollients.
- Use uncontaminated outer coverings when smoking.
- Holistic risk assessments by health and care professionals should be conducted and recorded in care plans.

Fire Safety in Care Settings:

- Referral processes for home fire safety checks discussed.
- Telecare systems with smoke detectors recommended for high-risk individuals.



Emollient Fire Risk Awareness webinar

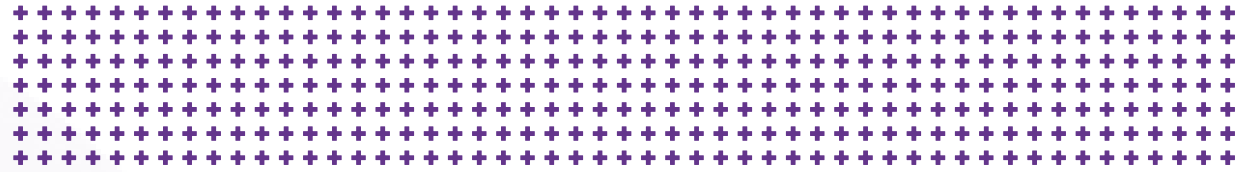
- Reporting fire incidents involving emollients via the MHRA scheme is crucial.
- Portable fire suppression units considered a last line of defence.
- Responsibility for fire safety equipment varies by setting.
- Broader project work includes training, assessments, and awareness campaigns.

Emollient Fire Risk Management Project:

- Webinars reached over 700 attendees; training incorporated into provider contracts.
- Collaboration with local carer advocacy groups and development of Easy Read materials.
- Outcomes: improved reporting, amendments to nursing assessments, better risk identification and management.
- Project received awards for partnership and collaborative working; resources available on KnowledgeNow.

Risk Assessment and Prevention Measures:

- Emphasis on staff education and training in fire safety practices.
- Encouragement for attendees to review risk assessments.
- Recommendation to implement telecare with linked monitor fire detection systems.
- Consideration of costs for misting units as part of fire prevention strategies.
